The Novice Rider Course (NRC) is tailored to provide the basic skills (both mental and physical) needed to ride safely. **Students under the age of 18 must either have a parent/guardian notarize our Waiver and Release of Liability OR have parent/guardian sign our Waiver and Release of Liability in front of an instructor.**

The Intermediate Rider Course (IRC) gives students an opportunity to improve riding skills on their own motorcycles. Students must have a minimum of 3000 miles and 90 days of riding experience, and have a motorcycle learner's permit or endorsement to enroll. Be prepared to show license and proof of insurance to the instructor. All participants must sign our Waiver and Release of Liability.

WAIVER AND RELEASE OF LIABILITY
