## RELEASE, WAIVER AND INDEMNIFICATION

In consideration of the Motorcycle Safety Foundation furnishing services and/or equipment to enable me to participate in the Motorcycle Rider Education Class, I agree as follows:

I fully understand and acknowledge that: (a) risks and dangers exist in my use of motorcycles and motorcycle equipment and my participation in the Motorcycle Rider Education Class activities; (b) my participation in such activities and /or use of such equipment may result in injury or illness including, without limitation, bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of the Motorcycle Safety Foundation, including all Rider Coaches/Instructors and RERP sponsors, the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature and/or other causes, and that these risks and dangers may arise from foreseeable or unforeseeable causes; and (d) by my participation in these activities and/or use of equipment, I hereby expressly assume all risks and dangers and all responsibility for any losses and/or damages, whether cause in whole or in part by the negligence or other conduct of the owners, agents, officers, or employees of the Motorcycle Safety Foundation including all Rider Coaches/Instructors and RERP sponsors, or by any other person.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify the Motorcycle Safety Foundation and its owners, agents, officers, employees, Rider Coaches/Instructors and RERP sponsors from any and all claims, suits or causes of action for bodily injury, property damage wrongful death, loss of services or otherwise which may arise out of my use of motorcycles and motorcycle equipment and /or my participation in the Motorcycle Rider Education class activities. I specifically understand and agree that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the Motorcycle Safety Foundation and its owners, agents, officers, employees, Rider Coaches/Instructors or RERP sponsors.

I HAVE READ THE ABOVE WAIVER AND RELEASE, AND BY SIGNING IT, AGREE IT IS MY INTENTION TO EXEMPT AND RELIEVE THE MOTORCYCLE SAFETY FOUNDATION FROM ANY AND ALL LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE AND/OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSES.
